This meeting was the first one with new Magistrates Mike Lockard, Kenneth "Goat" Rice, Timmy Tipton along with the only returning Magistrate Donna Gabbard. Keith Hall, who was also elected, had to miss the meeting due to a job related training session.

First item was a proposal by Powell County Jailer Travis Crabtree. The county has been looking at refinancing the debt that is still owed on the jail facility and Mr. Crabtree thought it would be a good time to look at a possible expansion then tie the two together. He said the jail has been filling up quite often in the past years and the county often has to house inmates in the in Montgomery County. The jailer asked the magistrates to approve a plan to seek design and construction proposals, while doing a study to see if the expansion is feasible for the county.

The county could add around 100 beds and make it look more like a regionalized jail. This expansion would enable the jail to enter into contracts with other counties to house their prisoners in Powell County. This could generate some revenue to help with the debt and other costs. Magistrate Mike Lockard asks if local banks would have a chance to bid for the refinancing. Mr. Crabtree had R.J. Palmer from Civic, a company that helps with financial issues, at the meeting. Mr. Palmer assured Magistrate Lockard that local banks would have the chance to bid as well. Judge Anderson told members and the crowd that some changes were coming to jails. Some of those changes deal with lighting issues and how the doors need to operate.

Court had discussion about the state gas tax issue. Judge Anderson told members and the public if the Legislature fails to address the issue, Powell County will lose money in FY 2015 and FY 2016. It will be devastating to Powell County in our ability to adequately address our infrastructure needs. In an effort to make sure those Powell County representatives in the House and Senate are aware of how important it is to address this issue Judge Anderson discussed passing a Resolution supporting passage of road fund stabilization by the 2015 Kentucky General Assembly.

No action taken

Powell County Clerk Rhonda Barnett and Powell County Sheriff Danny Rogers were present at the meeting to present their 2015 Budgets.

Ms. Barnett was the first to present her 2015 Budget along with the annual order setting maximum amount for deputies and assistants.

The county's clerk budget estimated revenue is \$2,547,500.00 while disbursing \$2,547,350.00. That would leave an excess in fees collected of \$4,150.00. A motion was made by Magistrate Timmy Tipton and then was seconded by Magistrate Donna Gabbard to approve the Clerk's 2015 budget as presented.

The next item for discussion was Road, which revolved around culverts. Citing that runoff from rains have become a problem in some areas of the county especially during the colder months when it can turn to ice, Magistrate Timmy Tipton asked if there could be an ordinance passed to place a minimum size for culverts used. The culverts are suggested to be 12 inch pipes, but due to cost some have placed smaller ones and they cannot handle the runoff which creates an overflow situation. Tipton also said "It is becoming a safety hazard for school buses and even mail carriers, as well for the road workers doing the maintenance on the roads". Tipton's proposal for an ordinance would ask that those wanting to place a culvert that may affect a county road would be required to seek a permit from the county. After some discussion with Powell County Attorney Robert King said he would have a proposed ordinance ready for the 1st reading at the next month's meeting for February 10th, 2015.
