## POWELL COUNTY FISCAL COURT SPECIAL CALLED MEETING MARCH 17<sup>TH</sup>, 2015 6:00 p.m.

Judge Anderson called meeting to order

Judge Anderson asked the Clerk for roll call for Magistrates present:

Powell County Sheriff Danny Rogers was first on the agenda. He was present at the meeting to present a resolution for the approval to purchase three (3) cruisers. (2015 dodge chargers)

He told members that he had advertised for bids in the newspaper but got no response. He said he had talked to Jim at Freedom Dodge in Lexington, Kentucky. This is the only dealership in the state that offered the state contract price. Mr. Rogers said that he also had talked to Darrell Billings at Tanner Dodge and Mr. Billings said he would match the state contract price. Mr. Rogers said the price per vehicle would be \$24,618.20. County Attorney advised that the dealership that gets the state contract price has to be the one that you purchase from. Judge Anderson asked the sheriff how many the county would have to maintain on the insurance. Mr. Rogers told him it would be around 13 to 14 vehicles. Judge Anderson said going into our budget year we have really never set a threshold and it would be good to have an amount to budget.

After a lengthy discussion the county attorney changed some of the language in the resolution. (Resolution will follow minutes.)

A motion was made by Magistrate Keith Hall and then was seconded by Magistrate Mike Lockard to approve the resolution for the sheriff to purchase three (3) cruisers (2015 dodge chargers) in the amount of \$24,618.20 plus financing.
