Judge Anderson asked the Clerk to call roll for Magistrates in attendance

Keagan O'Daniel representing Allstate Towers opened the meeting with public comments. He was present at the meeting questioning an outstanding invoice in the amount of \$116,000.00.

Powell County Public Library Director Julie Carroll was present at the meeting to present their 2015 tax rates along with their August 2015 meeting minutes.

Discussion of Old Business:

Gary Lederer the Operations Manager with Rumpke was present at the meeting to answer any questions they may have concerning the garbage bid that was presented at last month's meeting. Court members questioned him about the rate increase and ask of there may be some negotiating on the rate. Judge Anderson stressed how this rate increase would be hard for customers on a fixed income. Mr. Lederer said they could contact Stacey Chambers on Monday to discuss concerns they may have.

Next was sealed bids submitted for Powell County Star Gap Road, Sand Lick Road and Halls Hill Road slide repair's. The 2 bids submitted were from Hinkle Environmental Services, LLC and King-Crete Ready Mix Inc.

Judge Anderson presented and opened the sealed bid submitted from Hinkle Environmental Services, LLC.

Total 7 (seven) Projects combined totaled - \$255,205.00

This company noted they could start the projects as soon as next day after bid award.

Judge Anderson presented and opened the sealed bid submitted from Red River Ranch (RRR).

The bid amount for labor and materials for this said project was in the amount of \$169,452.00. Mr. McCormick told court members that he would submit the bid to the state for them to review.

Judge Anderson made Court aware that there would be a surplus property auction on September 26th, 2015 at 10:00 a.m. at the former Burke Parson's Bowlby location.

Next Judge Anderson presented an Order of Affiliation

The purpose of the Executive Order is to outline the responsibilities of the Powell County Fiscal Court and the Powell County Search and Rescue Team. The Powell County Search and Rescue Squad are the only officially recognized Search and

Rescue Team in Powell County. By virtue of this order, they are official affiliated with the Powell County Fiscal Court and the Powell County Emergency

Management Agency.

A motion was made by Magistrate Timmy Tipton and then was seconded by Magistrate Kenneth Rice to approve and adopt this affiliation agreement and give Judge Anderson the authority to sign it.

The court move on to New Business:

Sherry Skidmore with the Powell County Sheriff's office was present for the meeting to present court members with their 2014 sheriff's tax settlement. She also presented a report showing the 2014 Franchise Collection.
