Judge Anderson called this special meeting to Order

Judge Anderson asked the Clerk to call roll for Magistrates in attendance.

First item on the agenda was the garbage contract with Rumpke.

Judge Anderson told court members that he had spoken with the President of the company about his concerns with the price increase as well as the professionalism with Ms. Chambers. After the discussion the Judge told court members that the gentlemen he had spoken with said he felt like the county had received a fair bid. Magistrate Timmy Tipton said the county should explore other options in the future.

A motion was made by Magistrate Timmy Tipton and was seconded by Magistrate Mike Lockard to go with the three (3) year thirty (30) day OPT out plan contract. The cost for residential customers on a monthly basis will be \$17.00. The cost of commercial customers on a monthly basis will be \$35.27. The contract will begin October 1, 2015 and continue through September 30th, 2018. This contract also states it may be renewed for additional option years upon mutual agreement of both parties.

The bids received were submitted from King-Crete and Hinkle Environmental Services LLC. The court decided to take no action at that time.

Road Slips once again was put on the agenda for this special called meeting. After discussing both bids received the court voted to go with the lowest bid received from King-Crete. The court discussed appointing an inspector to over-see the work progress for these project's until completion.

Mr. Lindon recommended that we move forward in the replacement of Popular Bluff Bridge. Judge Anderson opened the seal bid that was submitted from John Baker, Shane Bowen and Barry Ewen to do the replacement of the bridge. The bid amount was \$24,900.00. A motion was made by Judge Anderson and then was seconded by Magistrate Keith Hall to wait on the replacement of the bridge until we know the county will be awarded funding for this project.
