Judge Anderson called the meeting to Order at 6:00 p.m.

Judge Anderson ask the Clerk to call roll:

Judge Anderson ask for a moment of silence for the passing of Mike Gabbard spouse of Magistrate Donna Gabbard and the former County Judge Executive Forest Meadows.

The meeting began with approving the Clerk's report for the two October meetings. A motion was made by Magistrate Tipton seconded by Magistrate Hall to approve the Clerk's report for the regular called meeting dated October  $10^{\text{th}}$ , 2017.

#### Old Business:

Judge Anderson made court aware that he had received a road salt quote for the upcoming winter months from Detroit Salt in the amount of \$84.21 per ton (A maximum of 300 tons). This price includes all delivery costs to the delivery location.

#### **New Business:**

Next on the agenda was the discussion of the Wrecker Services in the county.

During last month's meeting the court had discussed getting a written wrecker policy together. Since then a meeting was held with them to discuss the policy to make sure they agreed with it. They also was present for this meeting and Judge Anderson welcomed them to look over the policy to make sure they didn't want to make any changes to it.

Judge Anderson told members that there had never been a written policy in place to how the wrecker services would be dispatched. Magistrate Lockard ask if there was any services out of the county on the list

Judge Anderson told him that was one of the changes they had made.

#5. Any new wrecker service added to the list must maintain an operational wrecker within the boundaries of Powell County. Exceptions may be made for services Powell County, but will not continue under a change ownership. The other change was to #4. The wrecker must be en route to the scene with 10 minutes instead of 5 minutes listed before. After discussion and agreement a motion was made by Magistrate Hall seconded by Magistrate Lockard to approve the wrecker policy.

The ninth bid opened was from Hinkle Construction Services, LLC. The bid amount were as follows: Fife Lick Road Culvert, Little Hardwicks Road Culvert, Millstone Road Bridge, and Poplar Bluff Culvert Replacement Combined Bid - \$306,000.00 (net saving of \$10,050.00)

The tenth bid opened was from AEJ Construction Co. The bid amount were as follows: Poplar Bluff Road Culvert Replacement - \$65,722.47

The eleventh bid opened was from Hinkle Construction Services, LLC. The bid amount were as follows: Poplar Bluff Road Culvert Replacement - \$62,200.00

The twelfth bid opened was from HEJ Construction CO. The bid amount were as follows: Mill Stone Road Culvert Replacement - \$145,000.00

The thirteenth bid opened was from Hinkle Construction Services. The bid amount were as follows: Mill Stone Road Bridge Replacement – \$161,500.00

After reviewing all the bids and contingent on Blake Adams review a motion was made by Magistrate Tipton seconded by Magistrate Lockard to go with the lowest bidder King Crete Drilling Inc. Total of all projects would be in the amount of \$161,995.00.
