## New Business:

Gary Napier and Johnny Stokley was present for the meeting on behalf of the Powell County Soil Conservation They come to see what the possibility would be of them obtaining additional funding for their district. They told the court that as of this time they will not be getting any kind of direct aid from the state. If they receive no direct aid and the county cannot help out they will be forced to close their doors. Magistrate Tipton told them even though if we could work out giving more funding for them this year does not mean we can do it in years to come. The court agreed that they would take an additional look at additional funding once we know what the retirement and insurance costs are going to be in the upcoming county budget. Judge Anderson made them aware that the county had budgeted \$20,000.00 in the 2018/2019 budget which they can receive this after July 1, 2018.

Discussion about the county needing a credit card to use for training and lodging.

- EOC fencing \$35,000
- Black Creek fencing \$10,000.00
- Black Creek isolation transformer \$10,000.00
- Black Creek alarm/monitoring system \$6,000.00

Funding has already been allocated and quotes for projects have been received or are being requested. KYEM will conduct a quarterly site visit on Friday the 11<sup>th</sup> of May at 10:00 a.m. They will review the CSEPP program and suggest improvements if needed. On Tuesday May 15<sup>th</sup> FEMA and KYEM will conduct a tech assist visit to help plan the annual drill held in September.

Mr. Babcock made the court aware that he had attended the annual CSEPP exercise in Pueblo Colorado which will help with the Kentucky CSEPP exercise, especially in Powell County in the fall.

Judge Anderson discussed the Cascade system.



Middle Fork and Clay City Fire Departments estimate was a little over \$7,700.00 to get the system in. John Koontz is supposed to look into doing the wiring for this project. It's a 3 phase currently switching out verses bringing 3 phase into the Fire Departments.

Discussion of Hatchers Creek Road (CR-1018).

Judge Anderson declared an Emergency Declaration on Hatchers Creek Road (CR-1018). This declaration is in an effort to try and receive emergency funding to correct an issue caused by a storm event that damaged a stream bank and is putting the road in jeopardy.
