A committee was put together to fill out a score sheet for each firm. Those sitting on the committee were Jackie Everman, Craig Dawson and Judge Anderson.

The scoring consisted of:

- 1. Ability of Firm to perform the required tasks within an allotted timeframe (20pts)
- 2. Experience of proposed principals (20pts)
- 3. Recently completed projects of similar scope (20pts)
- 4. Familiarity and understanding of potential funding entities (10pts)
- 5. A brief profile of Firm's history, principals, staff and facilities (5pts)
- 6. Understanding of the Powell County EMS Renovation Project (25pts) Total (100 pts)
