Public Comments:

Two gentlemen was present for meeting to address the court.

Mr. Gibbs approached the court a few months ago asking about this. He told court members that Powell County is currently operating with one inspector that only inspects one day a week. Mr. Gibbs said he gets several calls about inspections and he feels there is a great need to have more availability for services. Court members agreed to let the building and grounds committee review his request and make a recommendation to the court before the next fiscal court meeting.

No Action taken at this time

Ken Howard who volunteers to operate our HAMM radio systems. Mr. Howard ask the court members if they had an after action report for the recent CSEPP Exercise Drill. Judge Anderson told him that Mr. Babcock would not be present for the meeting to present the report due to two deaths in his immediate family. Mr. Howard told court members that the recent drill went well and FEMA gave them a good report. Judge Anderson said he would like to thank Mr. Howard for volunteering his time in making these exercises a success. He also has been instrumental in helping us get the system and equipment we need to have capabilities.

Mr. Howard said that he appreciates Mr. Babcock and Mr. Asbury and wants to continue to work with them as long as he can.

Old Business:

Powell County Health Department right of way for the 213 project:

Court members discussed the Powell County Health Department right of way for the 213 project. Project Description: Improve Safety and Geometrics, and Reduce Congestion KY-213 from KY-11 to bottom of Mountain. (12CCR) (16CCR).

The county received a check in the amount of \$9,125.00. The check was made payable to the Powell County Fiscal Court General Fund. The amount of the check was broken down the following way (all documents will follow minutes).

Asphalt Paving Carmen's landing: (the new watercraft takeout off of 7th St. in Clay City) Magistrate Tipton once again excused himself from the meeting while quotes and voting where being discussed in order to avoid any perceived conflicts even though we're confident that isn't an issue. Hinkle Contracting had donated base to make a circle loop but now it needs to be paved.

Judge Anderson has spoken with Clay City Mayor Bobby Carmichael about the need for it to be paved. Mr. Carmichael also discussed this with their tourism commission. They are requesting that the county pay for this project to complete the whole loop. The City of Clay City would then reimburse the county for the whole amount.

The Judge received a quote from Hinkle Contracting to do the paving in the amount of \$12,582.00. Place and compact bituminous binder (2.5"compacted depth)

Road Salt:

Judge Anderson made court members aware that the advertising for a salt quote was published in the local newspaper for the upcoming year.

At this time we have not received any quotes. He told them he had reached out to Detroit Salt because they have been the lowest quotes thus far and had the best delivery times. As of this time he hasn't heard back from them.

A motion was made by Magistrate Tipton seconded by Magistrate Patton to authorize Judge Anderson to buy up to 300 tons of salt spending no more than \$27,000.00.

Department Head Updates:

Magistrate Tipton ask Recycling Coordinator Chris Chaney if they were using the scales at the transfer station at this time. Mr. Chaney told him that Solid Waste Coordinator Tim Snowden knew more about the scales than he did. Judge Anderson told court members that they were close to using them but Mr. Snowden had been out with a non-work related injury for the last 6 months.

Mr. Chaney made court members aware that two (2) new trailers were purchased out of the recycling grant that we received this year along with seven (7) new stationary containers. He said they look a lot better than the previous ones and can collect cardboard. They contain a slot for cardboard so it actually has to be broken down before putting it into the container therefore more gets in there with less garbage.

He said this coming year he would like to get enough of new containers to finish replacing the wooden ones at the schools and maybe a few others places. He told them that the trailers are working out well also.

Magistrate Patton ask him if we were hauling our own cardboard and Mr. Chaney told Magistrate Patton that Central Kentucky Fiber out of Lexington comes and picks it up. Mr. Chaney said that he takes things off such as metal, batteries, copper, brass, etc. in the roll off trailer.

Judge Anderson said the recycling generates some revenue but nowhere near off sets the costs. He said we are doing our businesses more of a favor than anything.

DES Coordinator Steve Asbury said the he would like to thank the Powell County Board of Education for partnering with the county in giving us a site for our Mesnet station. The HNP grant application was turned in last week and the grants manager at UK has looked it over and said that is looks good. We are just waiting on the allocation of funds.

Mr. Asbury said he would like to thank Road Foreman Aaron Marcee publically for helping the county get money back from the disaster that happened back in March of this year. FEMA ask for documents concerning this disaster so the county could receive the funds. Mr. Asbury told court members that he appreciated Mr. Marcee and Finance Office Kacey Davidson for helping him find all of the documents that were needed for this disaster.

Mr. Asbury spoke about the flash flood on High Rock Road. He said himself along with Judge Anderson has been looking into it. The Department of Water has lots of permits but they finally got some clarification.

The flash flood left a lot of debris behind in the creek river. Judge Anderson was wanting to explore the option of getting that sediment out. Mr. Asbury said it can be done without being permitted per the Division of Water. Under the Clean Water Act 401 we can do it and the work must be conducted from the bank and any of the sediment that is removed up to one (1) foot cannot remain in the flood zone. Mr. Asbury told the Magistrates to refer to the map that he had given them to see where the flood zone was located. The back yards cannot be dug out and left it would have to be moved. So as long as the work is done from the bank the debris can be removed.

Judge Anderson said the flood was probably caused by a culvert up above that formed a dam wall and there was like five (5) inches of rain in a short time. The creek no longer exists and all the debris came out and was flowing through yards. He said the creek is private property which nobody per say owns so we are checking to see if anything could be done. He told court members that he wanted to get advice from the County Attorney. We probably will have to have an operator and there would have to be waivers. Magistrate Tipton said that he thinks there should be some kind of contract or transaction between some entity and the Army Corp of Engineering before you go onto the property and dig it up. Judge Anderson said he would ask the County Attorney if he could draft the proper documentations concerning this before proceeding.

Ambulance Director Nathan Hall made the court aware that a deer had struck the Mercedes Ambulance and someone had back into another one. They are working out a payment plan with the person that backed into the ambulance because they did not have insurance. He will sending them to Patrick's Collision for repairs.

Mr. Tipton ask Mr. Hall if they had been doing their own oil changes and maintenance for the ambulances. Mr. Hall told Magistrate Tipton that they had been doing their own simple maintenance things such as oil changes, brakes and tire rotations.

Assistant County Attorney Richard Fain ask Road Foreman Aaron Marsee if there would be anyway they could bring some big rocks to fill in a ditch on Caudill Road. He said he was afraid that there would be an accident. He told Mr. Fain he would check on it for him.

Mr. Asbury made the court members aware that there is a FEMA meeting this Thursday. He told court members that anything that we have done thus far has been approved. Judge Anderson said we need to make sure that Cow Creek and Mill Knob is approved so we can put these projects out to bid. Mr. Asbury said that he is waiting for FEMA to do the scope of work paper so that it can be put in the paper to be used for the bid.

Road Foreman Aaron Marsee gave each Magistrate a copy of the Scope of Work Report for October 2019. Court members are always happy and pleased to receive these reports. This way court members know what has been done for that month. This report lists dates, location of work, districts and the scope of work.

Mr. Chaney said he would like to make court members aware that he would be reporting the meetings for the Clay City Times. There also needs to be some clarification on the CBD oils or anything that would show up in a drug screening as an illegal drug. Court members said that they may not be opposed to it but as long as it shows up as an illegal substance it could affect this person's employment.
