## **Department Head Updates:**

#### CSEPP/EMA Director Kevin Babcock:

Kevin made members of the court aware that the EOC building was in the process of getting painted and should be completed in the next week or so. Kevin told members that he had a local company that contacted Larry Means to do the painting project. Once the painting project is complete Kevin ask for court approval to move forward with paying for the project. The total amount for the project is \$12,600.00. Members of the court had no objections to this request to pay \$12,600.00 for the completed painting project for the EOC building. These funds will be taken from the CSEPP budget. Kevin showed members of the court a picture (Powell County Emergency Operations Center) that was going to be painted on the wall. This picture will recognize one logo for fire department, one logo for police department, one local for EMS and one logo for each different entity with the exception of EM.

He ask them to look at the picture to see if they would like any changes to be made to it. A local artist will be doing this painting.

The CSEPP had \$22,000.00 budgeted for trailer covering but this amount will not cover the 6x6's, the wood and the stuff that was originally wanted. Versa Tube which is a national company will make a 60 x 22 and with the court's permission he would like to move forward with this purchase. This will be put behind the new EMS site. Within the CSEPP budget Kevin was given authority to make purchases. CSEPP will also be purchasing a new 12X15 tent for public information which will cost around \$1,600.00 to \$1,700.00. Some of the places that the tent can be used would be at the fair and the corn festival.

Kevin talked to David Roar about the problems with the radios. David assured him that all 16 receivers and transmitters are working at all four sites. There is a problem with EC1 but they are doing everything possible that the radios are functioning correctly. There will be some changes made in the fall they will be redoing all of the transmitters and microwave system. There are looking into reallocating some money for a mobile unit. If it works then more money can be relocated next year so that they can be put in ambulances and maybe once in each fire department. The cost of the units are around \$8,000.00 to \$14,000.00 apiece. Kevin said he feels that CODERED is just valuable as the sirens.

On the sirens the National Weather and CODERED just before the last tornado warning and the thunderstorm warning they had a software issue where they were not talking. This created some delays. CODERED always hold it then they go ahead and submits it. It was resubmitted but past the

The tornado warning was for the North East Powell County and we were the last ones on the list to get a call from Jackson. By the time we got the call dispatch verify the call and activated the sirens but the storm had passed through.

#### Ambulance Director Nathan Hall:

Nathan told members of the court that they were still waiting Robin to get the contracts together for the remounts.

## Road Foreman Patrick McCoy:

Patrick made members of the court aware that they were doing vegetation removal. They have had several calls on tree branches protruding into the road ways so they are trying to get these calls taken care of. He wants to keep the slope mover going as much as possible. They have handled most of the calls they have had so far. They have completed the 2<sup>nd</sup> round of mowing. At this time they are taking a small break to let the grass catch back up. They are also doing ditches projects and have made a big push on Woody Ware Road to help correct some of the issues they are having on Shiloh Road. There is a list of roadways that he would like to see get ditched and completed this year. He also said they found another another culvert that needs replacing. Patrick said he had been working with Kevin and they went and assessed tower access roads. He have some recommendations to him so they will be helping to maintain them. Patrick also said he had been reviewing the tier system and is getting a list of recommendations.

Judge Anderson asked the Magistrates to resubmit a list of roads in their districts that needs paving. Magistrate Mike Lockard asked if he has heard anything about the exit on Woody Ware Road. Judge Anderson told him that he had received a letter from Mr. Saylers and it did look like there may be a possibility.
