Judge Executive Eddie Barnes called the meeting to order. Judge Executive Eddie Barnes led the Pledge of Allegiance. Roll Call for the following members. A quorum was established.

Public Comments:

Discussion of New Case Motor Grader (Wilson Equipment)

Rob Mahle, representing Wilson Equipment, was present at the meeting to answer any questions members of the court may have concerning the quote they submitted for a new Case 836C 4WD Motor Grader. This quote is in accordance with the current KY State Contract Master Agreement Pricing (MA 758 2300001529) pricing structure between the State and KY and Wilson Equipment Co. Case Motor Grader - \$340,309.00 31% Discount Off - \$105,495.79

KY MA Purchase Price - \$234,813.21

The Grader can be purchased in full or by the 5 Year lease payment option. 5.2500% (Annual) Payment Amortization Report will follow minutes.

This discussion will continue later when the court discusses agenda items.

(Robbie Richardson discussion via telephone)

Judge Barnes told members of the court Robbie Richardson would like them to call him so that he can speak to members of the court via telephone. His wife is sick and could not attend in person. Judge Barnes asked County Attorney Robert King if this was allowed. Robert asks what the call was concerning. Judge Barnes told him it was regarding an ambulance call. Robert told Judge Barnes this would be allowed.

Robbie offered extensive commentary regarding his appreciation of both Judge Barnes and Dispatch Director Larry Hall and their availability in times of need when he had an emergency relating to health matters and urgent medical transport. He had heard rumors about issues regarding ambulance service. Judge Barnes and Larry Hall have personally responded when he has directly called and requested their assistance.

Judge Barnes asked Robbie if he had called him beforehand referencing this call. Robbie said no, he did not.

Magistrate Chad Patton Robbie is he was talking about an ambulance transport. Robbie said when he calls 911, they request Eddie to come to their residence. Eddie told him he appreciated him and called him anytime.

Larry Hall said there were a couple of calls in question. Larry asks Robbie how he knew for him to come to his residence. Robbie told members he had called. He ask Larry to make sure his house was secure in case he had to ride in an ambulance with his wife. Larry said he will continue to help people. This job doesn't mean more to him than helping a citizen in need. Judge Barnes said he agrees.

Magistrate Brian McKinney asks Robbie what the issue was with the ambulance service when they came to his residence when he called 911. Robbie told him no he did not have an issue. Magistrate McKinney told him the ambulance service would come to his residence anytime he called. This would not be a problem.

The last time his wife went to the hospital he followed the ambulance to the hospital with no issue, but he did not see a paramedic sitting with his wife at the back of the ambulance. He does not want to get into it but feels it should have been investigated. His wife said she felt she didn't get the service she should have. Judge Barnes told Robbie he appreciated him and would come to assist him or his wife anytime.

Robbie's wife Kay got on the phone and said she trusts Eddie and appreciates him.

Old Business:

(Discussion of the Pirates 2A State Champ Commemorative signs)

Magistrate Dennis Combs asks about the signs. Judge Barnes told him he had talked with Corbitt Caudill at District 10 office today. At this time the state will not approve placement at the originally designated location at the Powell-Wolfe line and the Powell-Clark line along the Mountain Parkway. Judge Barnes said he had talked to Senator Smith, and he disagrees with the state's decision and a statement was made about the possibility of involving the matter with Representative Bill Wesley and appealing to his office for assistance in overturning the state's decision. As it stands, the plan is to install these signs at the off ramps coming off the parkway.

Department Head Updates:

Animal Control Officer Justin Wright:

Animal Control Officer Justin Wright let members of the court know about having sick pups at the animal shelter. 6 out of the 7 lived which was better than anticipated. The phone lines have been down so most calls have been going to the dispatch center. They have been getting things caught up around the shelter these past couple of weeks.

Judge Barnes asked if they still needed expired fluid. The ambulance service has some if they do. Justin said this would be great because they are giving 300 to 400 millimeters to seven different dogs each day.

Jailer Teddy Lacy:

Jailer Teddy Lacy told members of the court things are going good at the jail.

Solid Waste Coordinator Tim Snowden:

Solid Waste Coordinator Tim Snowden let members of the court know he got the truck back from Cobra Transmission and was running well. The truck needs a new battery, and the ABS brake system computer is not working. They quoted \$700.00 for a battery and repairing the ABS brake system.

Magistrate Mike Lockard asked him if it would be cheaper just to park it. Tim told him it's up to them what they wanted to do.

A motion was made by Magistrate Chad Patton and seconded by Magistrate Dennis Combs with all members present voting in favor of repairing the brake system computer and replacing the battery for this truck.

Motion passes unanimously.

Solid Wate Coordinator Tim Snowden let members of the court know Henderson County approved for us to purchase the conveyor system in the amount of \$2,000.00 which will come out of grant monies. Magistrate Mike Lockard told Tim he thought we were getting the system free if we disassembled it Tim told him we would have to pay for it, but he is working with Kentucky Beverage Control to see if they would help cover the expense of hauling it. He found a trailer to haul it which would help with the transportation cost. Judge Barnes asked if we purchased the conveyor how much time we would have to move it. Tim had told them we would get it as soon as we had things worked out. It would be bad to purchase it and not be able to haul it.

Tim has not had time to get the measurements for a new building.

Members of the court decided to table this discussion until we get what the final cost will be to haul the conveyor.

Road Supervisor Patrick McCoy:

Road Supervisor Patrick McCoy let members of the court know things are going well as far as the road department. They have several culverts and base failures to work on. Patrick mentioned in last month's meeting about Rumpke trucks damaging our county roadways. They must get these repaired so that they can start on the road list regarding our Flex funds.

The road crew has been cleaning up from the bad storms the county had associated with Helene. They still have some mowing left to do for the year, mostly in districts 4 and 5.

They have been working on grading gravel roadways.

There is still one vacant position for the road department. Patrick, along with Judge Barnes, reviewed some applications that were received. They have come up with a good applicant for this position. Members of the court reviewed the application.

Judge Barnes asks how much of the slope mowing they had done. Patrick told him most of the list was completed. There are still some that the school bus garage made them aware of.

Judge Barnes ask about the gravel for the Black Creek Tower. Patrick told him they had rocked it. Judge Barnes passed around pictures of the new building at Black Creek.

Patrick told members of the court the grader they currently have is at the end of its useful life. Judge Barnes ask what the difference would be between the old and new grader. Patrick told him the biggest thing would be the size. The current Caterpillar grader they have has a 12ft mow board. The grader discussion will be discussed when we get to the agenda items.

(Hiring Michael Whitehurst at the Powell County Road Department)

A motion was made by Magistrate J.L. Bowen and seconded by Magistrate Brian McKinney with all members present voting in favor of hiring Michael Whitehurst for the Powell County Road Department.

Motion passes unanimously.

Magistrate Chad Patton ask what his starting pay would be. Judge Barnes said we have some employees making \$12.00 an hour, some are making \$12.50 and some making \$13.00 per hour. Judge Barnes said he would like to see the starting pay at \$13.00 per hour across the board. Jailer Teddy Lacy asked if jail employees could also start their pay at \$13.00 per hour. Judge Barnes yes it would be across the board once we got it approved. Magistrate Brian McKinney said he thought this was a great idea.

Ambulance Director Arlene Rogers:

Purchase (2) Life Paks from Zoll Medical: To be paid from Ambulance Account)

Ambulance Director Arlene Rogers talked about them trading in (2) Life Paks from Zoll Medical. They only want to give us \$8,000.00 to trade in the two (2). Arlene called and they said we could purchase the two Life Paks for \$8,000.00 instead of doing the trade in.

A motion was made by Magistrate Brian McKinney and seconded by Magistrate Dennis Combs with all members present voting in favor of purchasing Life Paks from Zoll Medical. This purchase will be taken from the ambulance account in the amount of \$8,000.00.

Motion passes unanimously.

911 Director Larry Hall:

911 Director Larry Hall made members of the court aware of the run calls that came into the Dispatch Center for the month of September 2024.

Ambulance Service – 220 Clay City Fire - 14

Stanton Police Department - 204 Clay City Police Department - 14

Stanton Fire Department - 3 Sheriff's Office - 344

Middle Fork Fire Department - 1 Search and Rescue - 1

One of the dispatch employees had some difficulties in the first week of the academy. Larry said they had worked out an agreement with no cost to the county. This employee will reimburse the county for the week of the academy that she failed. She has already given her check to the Treasurer for this, which will be deposited into the dispatch account. This employee will sign up for the academy again and will be by the (1) year contract after graduation.

Larry thanked the inmates, Judge Barnes, road department, Megan Curtis along with others that helped during the past storm.

The estimated cost for the Black Creek Tower building was going to be \$22,349.00 but ended up costing \$24,552.64. CSEPP paid for the building in full. They are currently waiting for the radios to be installed.

911 Director Larry Hall told members of the court Mapping Officer Justin Rice was unable to attend the meeting due to a family emergency.

911 Director Larry Hall told members of the court he was made aware of some complaints concerning him. He said he would rather discuss this in open court instead of discussing it in closed session. He thinks the people of the county should get to hear what is said.

Larry said Judge Barnes called him into the office on Friday to talk about him going on (2) EMS calls.

Kay Richardson called and asked Larry to drive her husband Robbie to the hospital during her medical stay. Larry said he appreciates his job but if it becomes where he cannot help a friend then they will need to find a new director.

Larry provided documentation showing that a member of his household has a prescription. He said he has never possessed any medication from this county. He has talked to County Attorney Robert King about the charges for falsifying an incident. Larry was not at the ambulance service on 2/14 to get any medication. There was a question of the spring not working in the Epic pen.

As far as the complaint about him reporting the lights not working on the ambulance is true. Nathan Hall said the EMT that gave Eddie the medicine is out on a call and will return to the meeting when he's done with the run. Larry told Nathan that EMT did not sign the compliant he had signed it himself.

Assistant Tax Administrator Kevin Noel:

Assistant Tax Administrator Kevin Noel let members of the court know the collecting of business licenses and occupational taxes was going well. He had issued 46 pet licenses in the office as of today. Magistrate Brian McKinney told Kevin he appreciated the list he sent to them last month.

District Updates:

Magistrate Mike Lockard – He is glad we get to order the courthouse doors.

Magistrate Dennis Combs – Let members of the court know the company he works for donated gallons of bleach to the animal shelter which was delivered a week ago. He has contacted Bill Wesley about Highway 11 being one lane. Frankfort has called him a few times regarding this.

Magistrate J.L. Bowen – He is proud of what the guys done on the new building at Black Creek. This is so important for our communication. He has talked to Patrick about complaints regarding gravel roads.

Magistrate Brian McKinney - Powell County is one of the four counties in the state that did not have an LEPC (Local Emergency Planning Committee). They got together and formed one along with getting the bylaws in place. They will be official and certified in November and in compliance with the state.

There is an Opioid Symposium in a few weeks. Hopefully we will be able to start spending these funds. They will be discussing what to spend money on and what not to spend the money on. The counties not spending it correctly can be trouble.

During the last meeting they talked about partnering with a group in Clark County but the person we have been talking to has now quit the company. This would have been \$120,000.00 for 20 inmates for a year, which would have saved the county money in the future.

Brian met with the Beech Fork Water board today. A new committee was formed by using members from Stanton, Clay City and Powell tourisms along with themselves and a member of Beech Fork Reservoir. They are looking into all tourism boards working together to improve the Beech Fork Reservoir. They are currently working on getting the reservoir cleaned up and getting rock on the road. The long-term goal is to get the lake cleaned up. They are also talking about getting some drenching done in the back part and building up some parking areas for some fishing.

The Kentucky Fish and Wildlife are coming in April to do a shock test on the lake. They will also give us guidance on how to restock and what it will need.

They have talked to the Bass Team at the high school about doing some small events at the lake. They have also talked about building picnic shelters.

The goal is to get the reservoir cleaned up so the families in Powell County can utilize it in the future. We just need all (3) tourism boards to work together to make these things happen.

Magistrate Chad Patton: Everything good. The road department has done a great job in getting the trees cut from the storm. He asks if we have heard anything concerning out road lists. Judge Barnes told him we had been approved for Flex Funds. We must wait on Hinkle to start blacktopping.

Magistrate Patton said he thinks we should consider bidding for asphalt locally next time. He asks if Rumpke has said anything about using smaller trucks.

Judge Barnes asked the county attorney if there was a way the county could put a weight limit on the garbage trucks that travel on our smaller county roads. He said there should be an established weight limit already in place.

Judge Barnes said we will talk to Rumpke to see what can be done.

Judge Barnes – Talked about the recent storm. Everybody from the road department, dispatch, fire departments, and jail did an excellent job cleaning up debris from the storm. The dispatch kept everyone notified of what was happening. Larry and Justin took pictures to document the damage. Magistrate Chad Patton said he has had a few people asking where they could take their brush. Judge Barnes told him they could take it to the landfill or the animal shelter.

Judge Barnes made a verbal Emergency Declaration on Saturday regarding the storm and on Monday he did a written one. They completed the Emergency Management Survey 123 and were sent to the district office. Magistrate Bowen asks other than the roads, was there any infrastructure damage. Judge Barnes told him a tree fell on the water tank located on Pendelton Street, causing the electricity to go out. A new poll was installed.

A lady came in from Frankfort and donated free food. She fed at least 125 people. Food was also delivered to residents living at Evergreen. Clark Energy employees also were fed.

Judge Barnes said everyone has done a great job participating during the storm.

After the discussion, members of the court decided to table this discussion so we can check with KACO to see if they would have better rates for financing.

Road Supervisor Patrick McCoy said they did scope out 3 different machines and the specifications that Case gave us on this particular machine is exactly what they need. John Deere did not have an option for a smaller mow board.

In the caterpillar machine you cannot purchase one with a 10ft mow board, but you can purchase a 10 ft mow board separately. Other competitors had higher pricing.

All three quotes were state-governing pricing.

Dutch 's Chevrolet quote is the lower option. Road Laborer Steven Haddix said he had talked to Darrell at Tanner Dodge, and he said he could not find any three-quarter trucks. Magistrate Brian McKinney asked if we wanted to wait until Darrell could submit his bid. Magistrate Chad Patton said we have not had much luck with dodges in the past and suggested going with Chevrolet this time. Road Supervisor Patrick McCoy agreed to that. They have done a lot of repairs to the dodges in the past.

Magistrate Chad Patton ask if we already had the plows and boxes. Patrick told him we would need to purchase a plow mount specifically to fit these trucks. The price for a plow box would be \$4,960.00 plus freight.
